

Newfoundland and Labrador

COMMUNITY

Community Accounts Newfoundland and Labrador's system of Community Accounts endorsed by the Standing Senate Committee on Social Affairs, Science and Technology in its final report of the Senate Subcommittee on Population Health – A Healthy, Productive Canada: A Determinant of Health Approach. Committee recommended a Community Accounts system for all provinces.

DISABILITIES

Québec

DISABILITIES

Working group established in Saguenay-Lac-St-Jean region to link with integration and employment strategies for persons with disabilities (2008 program has a 10-year goal of reducing the unemployment gap by 50 percent between persons with and without disabilities).

The Bas-Saint-Laurent collaborative table on disabilities is producing a manual for parents with children 0 to 21 to help coordinate services and interventions to deal with disabilities (child care, care in school, accompaniment and supervision).



DISABILITIES

Charles Beer to conduct mandatory independent review of the *Accessibility for Ontarians with Disabilities Act*. Ontario will make the province accessible for people with disabilities by 2025 by breaking down barriers in key areas of everyday life.

Saskatchewan

CHILDREN

17 agencies will receive \$1.67 million in capital funding for 496 new child care spaces in 11 communities throughout the province (current budget set aside \$4.22 million for 1,000 new child care spaces by 2009-10, bringing the total of licensed child care spaces to 11,400).

HOUSING

\$3.8 million to develop new 40-unit affordable, supportive housing project for low-income persons in Regina. 32 units will serve people with serious mental illness, with remaining eight units for people with intellectual disabilities. Project is part of a \$76.9 million 2008 commitment to address wait list for specialized, residential and day-program services for people with intellectual disabilities.

Alberta

CHILDREN

\$1 million from 2009-10 child care budget for more than 300 new child care spaces for families accessing emergency and second-stage shelter services.

COMMUNITY

\$6 million of the Community Initiatives Program grant funding set aside for small, community-based, human service organizations and international development programs. Citizen advisory group will be established to provide guidance.

EDUCATION

\$4 million for tuition and cost-of-living subsidy to support up to 40 First Nations, Métis and Inuit adults in northern communities as they study to become teachers in the Community-Based Teacher Education Program. 800,000 bursary program for post-secondary students interested in teaching in northern Alberta.

HOUSING

\$386 million over next two years through amended Canada-Alberta Affordable Housing Program Agreement. It includes \$95 million in federal funding over two years under Canada's Economic Action Plan as part of one-time investment of more than \$2 billion to build new and renovate existing social housing in Canada. Alberta will contribute \$95 million over next two years.

\$8.9 million to Calgary Homeless Foundation for new housing initiative for up to 80 family housing units for families in Calgary that are homeless or at risk of being homeless, including those leaving domestic violence situations.

\$278 million in capital funding in 2009-10 for 2,200 more affordable housing units across the province. This is an increase of \$24 million from 2008-09.
